Dear Brewery,

The 9th annual Bike Brew Q event will be held July 27th, 2024 at the Great Bend Expo Complex in conjunction with the Cystic Fibrosis Foundation to raise money to find a cure. The event will feature two main events. We will kick off the day with a cycling event in the morning. Following the cycling event, we will have the Bike Brew Q Craft Beer Expo from 1-4 p.m. (with a VIP session from 12-1 p.m.)! Great Bend, Kansas has a population of about 16,000 and is the commerce hub for many smaller surrounding communities, bringing the area population to around 30,000 +.

Your attendance is requested for this event and we would love to help showcase your product!

We are offering either monetary compensation or you can donate your brews and services as an inkind donation to the CF Foundation. The breakdown is as follows: \$300 per brewery including booth space and necessary supplies (tables, chairs, ice, etc.).

For an in-kind donation, the brewery will supply their products without a fee but will receive a letter from the Cystic Fibrosis Foundation thanking them for their donation. This letter can then be presented to your tax professional with an estimated cost of product. The product donated can then be filed as a charitable donation. You will receive the necessary supplies with this option as well but no money will change hands. We completely understand that each brewery is different in terms of available funds, resources, etc.

Your participation will include free passes to the event, a complete promotional and marketing package (free publicity for your brewery), tables, chairs, ice, dump buckets, water stations, and garbage cans. You will need to provide beer, jockey boxes, CO2, tubs, signs, and any merchandise you wish. Of course, we would welcome your friends!

Beer vendors shall provide a Certificate of Insurance naming Bike Brew Q and hold Bike Brew Q and its agents as additionally insured <u>or</u> a copy of your liability insurance policy.

Beer vendors, their staff members and/or guests shall pour only two ounces of beer into attendees' glasses.

Beer vendors, their staff members and/or guests will consume any alcoholic beverages responsibly while serving beer during the festival. Beer vendors are responsible for their staff members and/or guests that are pouring for them.

Beer vendors, their staff members and/or guests understand that they will not serve any visibly intoxicated person, and in the event that they should encounter a visibly intoxicated person, they will notify a beer festival organizer or event security.

Beer vendors, their staff members and/or guests understand that beer shall only be served from behind the tables in the booth space.

Beer vendors are responsible for cleaning up and leaving their area and tables clean and free of trash. All trash will be put into the designated trash containers.

REQUEST TO PARTICIPATE IN SPECIAL EVENT BY Kansas Farm Winery, Microbrewery or Microdistillery Licensees

Who is required to complete this form?

Licensed Kansas farm wineries, microbreweries or microdistilleries who wish to participate in a special event monitored and regulated by the Alcoholic Beverage Control (ABC) and offer tastings of the wine, beer or spirits they manufacture. Tasting events must be held in a location that liquor by the drink is authorized.

In addition to offering tastings at the special event, K.S.A. 41-308a also allows Kansas farm wineries to sell unopened containers of wine manufactured by the farm winery if retail sales are authorized. The approved form must be displayed at the event.

No special event can be held on a premise that possesses a private club liquor license or cereal malt beverage license; or, in a location where liquor by the drink or retail sales are not authorized.

Instructions

Complete this form and return to the address or fax number above. Your request to participate <u>must</u> be received by the Director **at least ten (10) days** prior to the event. Failure to submit this notification **at least ten (10) days in advance** of the special event may subject the licensee to administrative penalties.


